Expert witnesses provide juries with much needed context and understanding in domestic violence cases. Similarly, experts are necessary to describe the serious lethality risks associated with strangulation. While experts can make or break a case at trial, finding experts to testify in domestic violence cases can be difficult. Different cases call for different kinds of expertise and, even when you have identified the right experts, you need to train them to testify effectively. This session will provide guidance and discussion on how to locate, pay for, and train potential experts in your community. We will also address training ideas to ensure attorneys in your office effectively utilize the experts you have.

Prosecutors handing domestic violence cases must be aware of the ethical challenges inherent in the investigation, prosecution, and victim services processes to ensure justice is being achieved. Ethical considerations may include confirmation bias, pressure on victims to testify, risk of false accusations, challenges of balancing victim autonomy with the government's need for protection, and Brady/disclosure obligations. This session will explore these issues and provide practical guidance on how to effectively address ethical situations as they arise.

As evidence becomes more digital it has become incumbent for Prosecutors to present digital evidence seamlessly. The Kings County District Attorney's Office and the NYS Office of Court Administration has invested resources into upgrading the Kings County courthouses. Kings County has 15 tech courtrooms in the Supreme Court and 1 in the Criminal Court. Assistant District Attorneys are taught how to use this courtroom technology and present evidence by the members of the Bureau of Litigation and Technology (BOLT). BOLT has also trained the defense bar and the judiciary on these courtrooms. In these courtrooms we have monitors for the jury, the witness, the parties, the defense and the spectators.
